Domestic Abuse Services

On the 1st April 2017, domestic abuse services in Kent changed. New area based integrated support services have replaced the IDVA service and the KCC contracts for refuges and floating support. Any clients in receipt of one of these services will be automatically transferred to the new service. For more information see our [website](#).

Mental Health Awareness Week

This week it is Mental Health Awareness Week; Mental Health issues affect 1 in 10 Young People in the UK and are becoming more common as society and technology develops.

In October 2016, YMCA and the NHS published a report entitled "I Am Whole" with the purpose of examining the stigma faced by young people experiencing mental health difficulties. The research gave young people a platform in which to share their views and stories.

Findings from the report show that three quarters of young people (75%) believe that people experiencing difficulties with their mental health are treated negatively as a result of stigma. More than one in three young people (38%) with mental health difficulties had felt the negative impact of stigma and more than one in three young people (37%) who experience this stigma did so at least once a week.

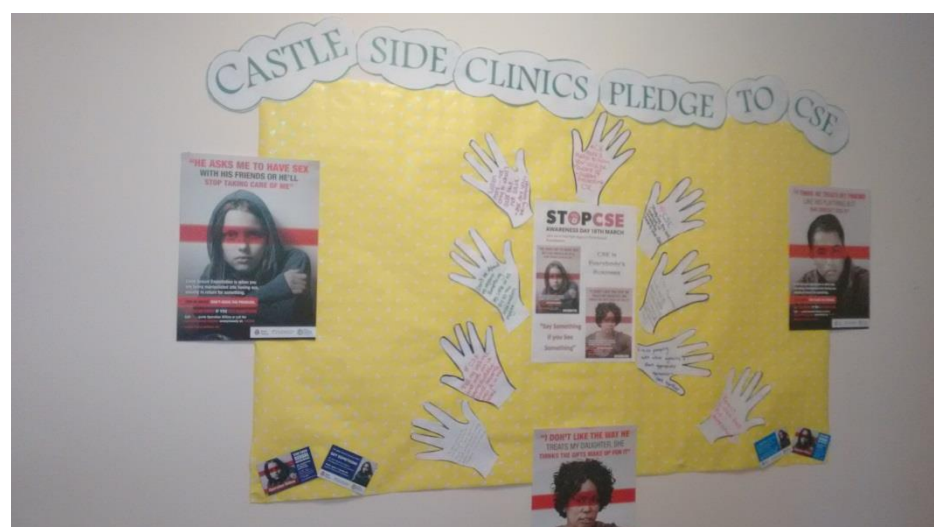
CSE Awareness Day - 2017

On the 18th March, the CSE Awareness Day took place. Partner Agencies and the CSE Champions arranged and participated in a number of events to promote the day and raise awareness of CSE with the general public and professionals. Below is a summary of some of the activity that took place:

- The Kaspar Fostering Agency promoted the use of the WudU? App, encouraging carers to install the App.
- Shepway Community Safety Partnership had a CSE Awareness stall, in Folkestone Town Centre on Saturday 18th March.
- On 15th March, in collaboration with KCC and Education and Young People Services, Operation Willow hosted a CSE Theatre production called Chelsea's Choice at the Kent police College for children in years nine and ten from across the county. This was positively received by teachers and the students.
- East Kent Hospitals Safeguarding team raised awareness of CSE to over 100 staff in the Quality and Innovation Hubs at K&C, WHH and QEQM hospitals over the week.
- By the Bridge with Cambian supported the 'Helping Hands' Campaign across the organisation, as staff helped by writing messages of support for tackling CSE on their hands, and coming up with an array of creative photographs.
- CAMHS hubs across the county participated in a CSE Pledge poster campaign using the concept from the CSE Social media campaign of writing pledges on hands; the photo below shows the artwork at Dover CAMHS.

Thank you to all our partners who participated in the awareness day this year, the above is just a small example of the excellent work of our colleagues to raise awareness of this issue.

Youth Empowerment Services CIC – The Know Project

In March 2017, Graham Godden from Youth Empowerment Services CIC delivered a presentation to the Board on their work with Kent Police. The Board was provided with an overview of their service and was particularly impressed with the sexual exploitation programme.

In partnership with Kent Police and The Know Project, Youth Empowerment Services CIC are offering **free** CSE awareness assembly presentations to secondary schools in Kent and Medway. Headstart

At the Board meeting in January 2017, Angela Ford from Headstart presented to the Board with the virtual assistance of two young people who provided commentary alongside a video. Headstart was funded by the Big Lottery Fund to support children and young people and equip them to cope better with difficult circumstances.

The Headstart Resilience Hub is for all 10-16 year olds, parents and teachers in Kent and aims to help people take care of their emotional health and resilience. Online Safeguarding Update

KSCB has developed a new Online Safeguarding Group with representatives from our multi-agency partners. The purpose of the group is to support the Board and its partners in their oversight of online safeguarding issues and ensuring that all agencies have a member of staff who can provide guidance on online safeguarding concerns. The first meeting took place on the 10th May and will convene on a quarterly basis.

Exploitation Risk Assessment

Following the review of CSE in Kent, one of the recommendations from the [KSCB Operation Lakeland Case Review](#) was to review the CSE Toolkit. After consultation with multi-agency partners, it has been decided that in Kent there will be a two-tier process covering all forms of exploitation.

Tier 1 –Risks Threats and Vulnerabilities Checklist

The Checklist is designed to be used by professionals from partner agencies (not SCS, YOS or Early Help). Its purpose is to support those professionals, with the help of their safeguarding lead, to decide on the appropriate action to support CYP. This may result in a referral to Early Help or SCS.

Tier 2 - Exploitation Risk Assessment

The risk assessment is for use by assessing staff (SCS, YOS and EHPS). This will replace the CSE Toolkit and should be used as part of ongoing planning and assessment work.

The Exploitation Risk Assessment will be launched this month

Consultancy Services

ECR

In April 2017, KSCB launched their new Electronic Case Review (ECR) system; ECR was designed by KSCB and built by QES who also created our ECDOP tool.

ECR is a secure online system that the KSCB Business Unit and its Case Review Members can use to record cases that are brought to the attention of the group through a Case Review Notification and therefore may be subject to a local learning review or serious case review.

If the decision is made to progress to a local review or serious case review, the KSCB Business Unit can use the system to securely and effectively undertake the case management of the review such as receiving agency reports and sending out agendas and minutes for panel meetings.

The process for sending a case review notification form to KSCB has therefore changed and we ask that forms are now submitted online (with no login required) by clicking new notification (top left hand corner) via the link here: <https://www.ges-online.com/Kent/ECR/Live/Login>
